Meeting began at 8:32 a.m. by President Mark Hassler. Officers Present – Daniel Gilbert and Mark Deckard. 19 others present.

Minutes of April 9, 2021, Meeting and Executive Officers Meeting Minutes of March 17, 2022* were accepted by Consent.

President's Report (Mark Hassler) – At this 2022 meeting we have 62 registrants, a total of 19 parallel session papers (including one student paper) and two presentations from our plenary speaker, Dr. Michael Grisanti.

Secretary-Treasurer's Report (Mark Deckard):

Finance Report - For Period of 4/1/2021-4/1/2022:

Starting Balance - \$4873.22, Income - \$1036.56, Expenses - \$1390.57, Ending Balance - \$4819.91. Additional Income - \$2002 = \$408 sent to ETS Main to start account there plus \$1000 annual stipend from ETS Main (see next note), plus \$594.20 refund of airfare from Michael Grisanti. And WordMp3 has registration income and royalty income which we will receive in May.

At some point in 2022 we will be transitioning the Bank account to ETS National as they are consolidating finances for the Regions at the Main office.

3rd Place: Donald C. McIntyre – "An Examination of Biblical Archaeology's Impact on Exegetical and Theological Method with Attendant Case Study"

2022-2023 Officer Candidates (Mark Deckard) – Due to the transitions resulting from the tragic death of our Secretary-Treasurer Gregg Strawbridge, changes were recommended from our normal pattern to help with the transition.

Recommendation by the Current officers to keep the traditional approach with progression from 2nd Vice-President up to President after this year. However, recommend that the Secretary-Treasurer now be a 3- year term staying in that office and is renewable for additional terms. Mark Deckard has
